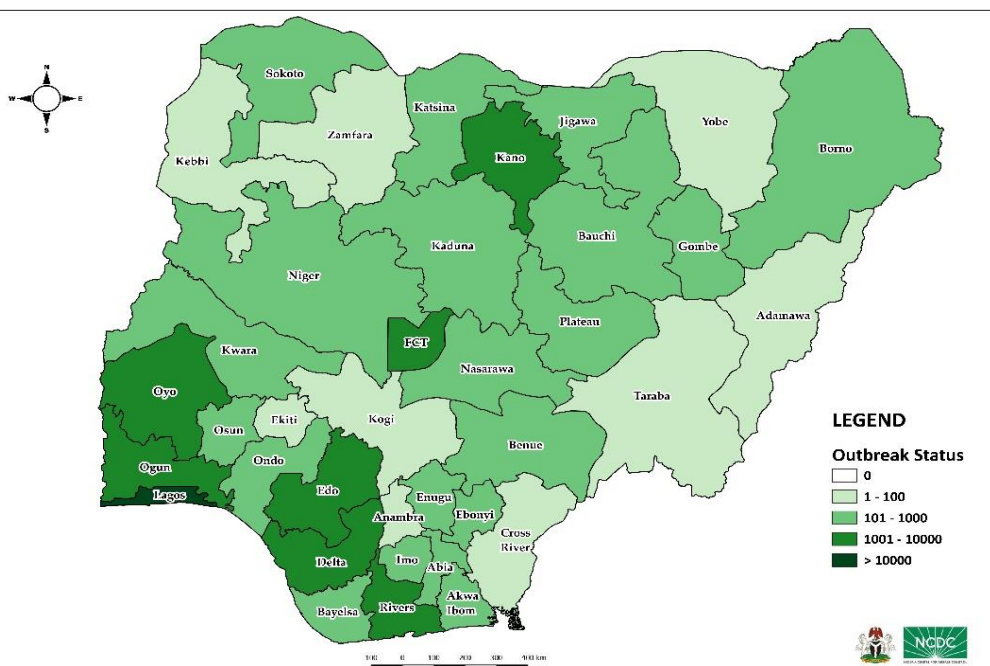
DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 8<sup>TH</sup> JULY 2020

### HIGHLIGHTS

- Four hundred and sixty (**460**) confirmed cases were reported in the last 24 hours from **21** states – Lagos (150), Rivers (49), Oyo (43), Delta (38), FCT (26), Anambra (20), Kano (20), Plateau (18), Edo (14), Bayelsa (13), Enugu (13), Osun (12), Kwara (10), Borno (8), Ogun (7), Kaduna (6), Imo (4), Bauchi (3), Gombe (3), Niger (2) and Adamawa (1).
- Two hundred and sixty-five (**265**) cases were discharged in the last 24 hours in **14** states – Ebonyi (71), Delta (47), Rivers (40), Edo (30), Bauchi (12), Ogun (11), Lagos (10), Sokoto (10), Kaduna (9), FCT (8), Gombe (7), Borno (5), Bayelsa (4) and Enugu (1).
- Fifteen (**15**) deaths were recorded in the last 24 hours in **eight** states – Delta (6), Edo (3), Bauchi (1), Bayelsa (1), Borno (1), Enugu (1), Ogun (1) and Rivers (1).
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

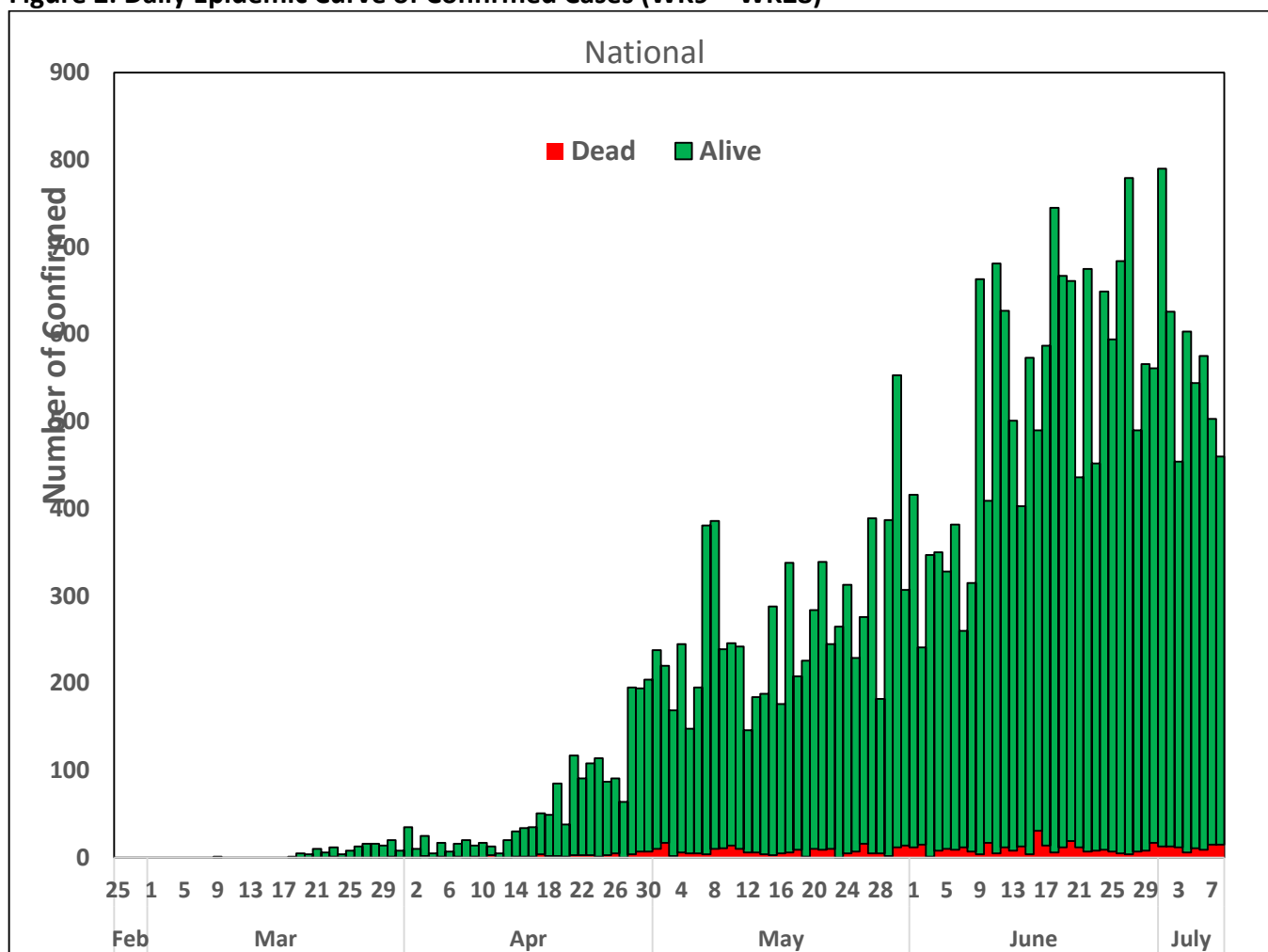

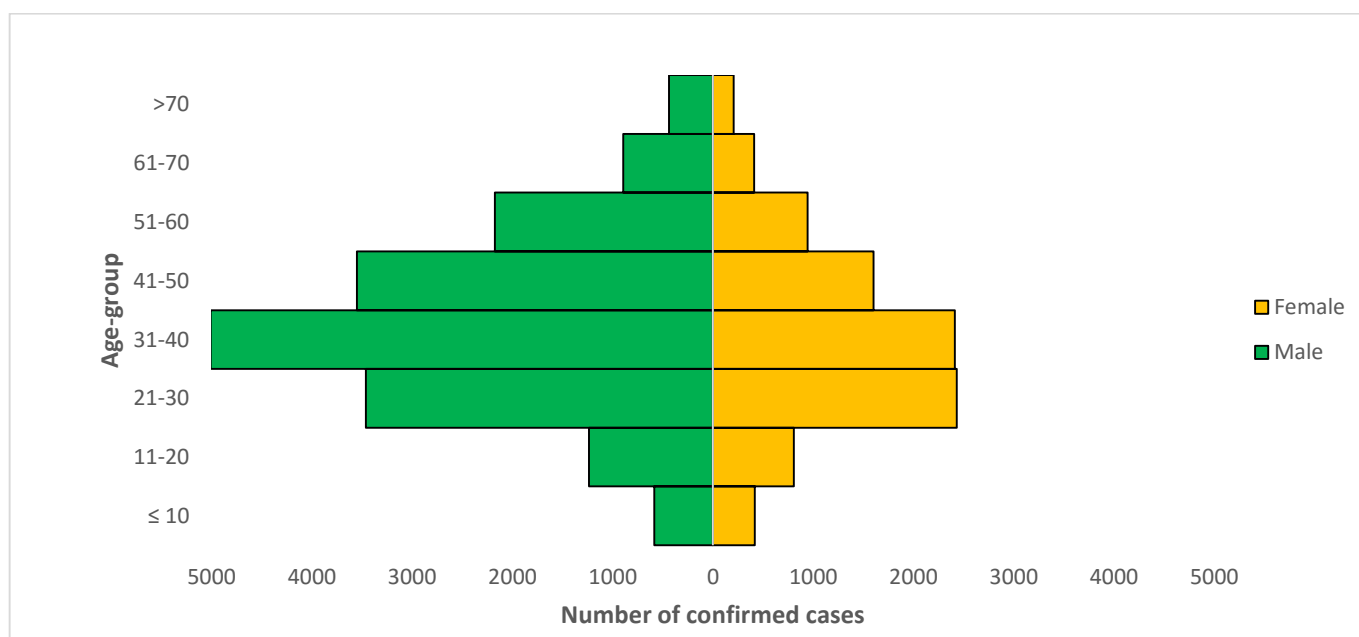

## PREPAREDNESS

Since the confirmation of the first case on 27<sup>th</sup> February 2020, the NCDC has released advisories and statements to help Nigerians and affected groups in particular to respond to the pandemic

## RESPONSE

On 28<sup>th</sup> February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Provided guidance and supportive supervision for triaging and hand hygiene compliance in Gombe State**
- **Setting up of triaging areas in health facilities across Enugu North, Enugu State**
- **Deployment of Personal Protective Equipment (PPE) to laboratories within the national network - Plateau, Borno and Rivers States**
- **Supplied PPE and case management commodities to University of Abuja Teaching Hospital, Gwagwalada (UATH) and National Hospital, Abuja**
- **Participated in a round table technical meeting with the Honourable Minister of State for Education, State Commissioners for Education and other education stakeholders to assess level of preparedness for schools reopening**
- **Conducted a strategic meeting with states response coordination teams to strengthen subnational level response**

- Deployed an additional Rapid Response Team (RRT) to Imo State
- Finalised the Local Government Areas (LGA) hotspot strategy document
- Implementation planning for the training of state teams on surveillance
- Activated new GeneXpert laboratory in Federal Medical Centre (FMC), Owerri
- Ongoing state level IPC training in Katsina State targeting health care workers at primary and secondary health facilities
- Ongoing supply of Personal Protective Equipment (PPE) commodities to Laboratory networks across four states Abia, Bauchi, Kano and Ondo
- Held a coordination meeting with the Nigeria Governors Forum to strengthen collaboration between states' task force and state social mobilisation committees
