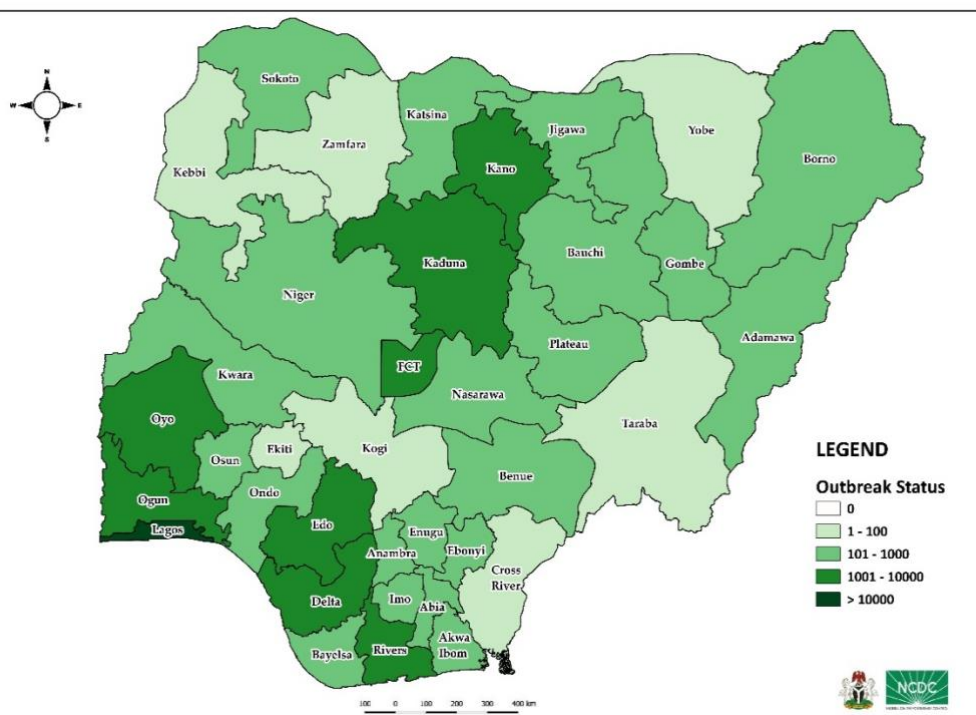
DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 18th JULY 2020

HIGHLIGHTS

- Six hundred and fifty-three (**653**) confirmed cases were reported in the last 24 hours from **28** states – Lagos (115), Kwara (85), Enugu (80), FCT (78), Rivers (36), Ondo (35), Oyo (30), Katsina (28), Abia (19), Kaduna (19), Nasarawa (18), Plateau (17), Imo (16), Benue (9), Ebonyi (9), Kano (9), Ogun (9), Delta (8), Bauchi (7), Ekiti (6), Adamawa (4), Bayelsa (4), Gombe (4), Osun (4), Borno (1), Cross River (1), Yobe (1) and Zamfara (1).
- Three hundred and five (**305**) cases were discharged in the last 24 hours in **15** states – Oyo (65), Ogun (57), Delta (45), Kano (29), Ebonyi (25), FCT (19), Gombe (18), Osun (15), Plateau (11), Rivers (11), Ondo (4), Benue (2), Yobe (2), Bauchi (1) and Kwara (1).
- **Six (6)** deaths were recorded in the last 24 hours in **five** states – Ebonyi (2), Enugu (1), Osun (1), Oyo (1) and Rivers (1).
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK29)

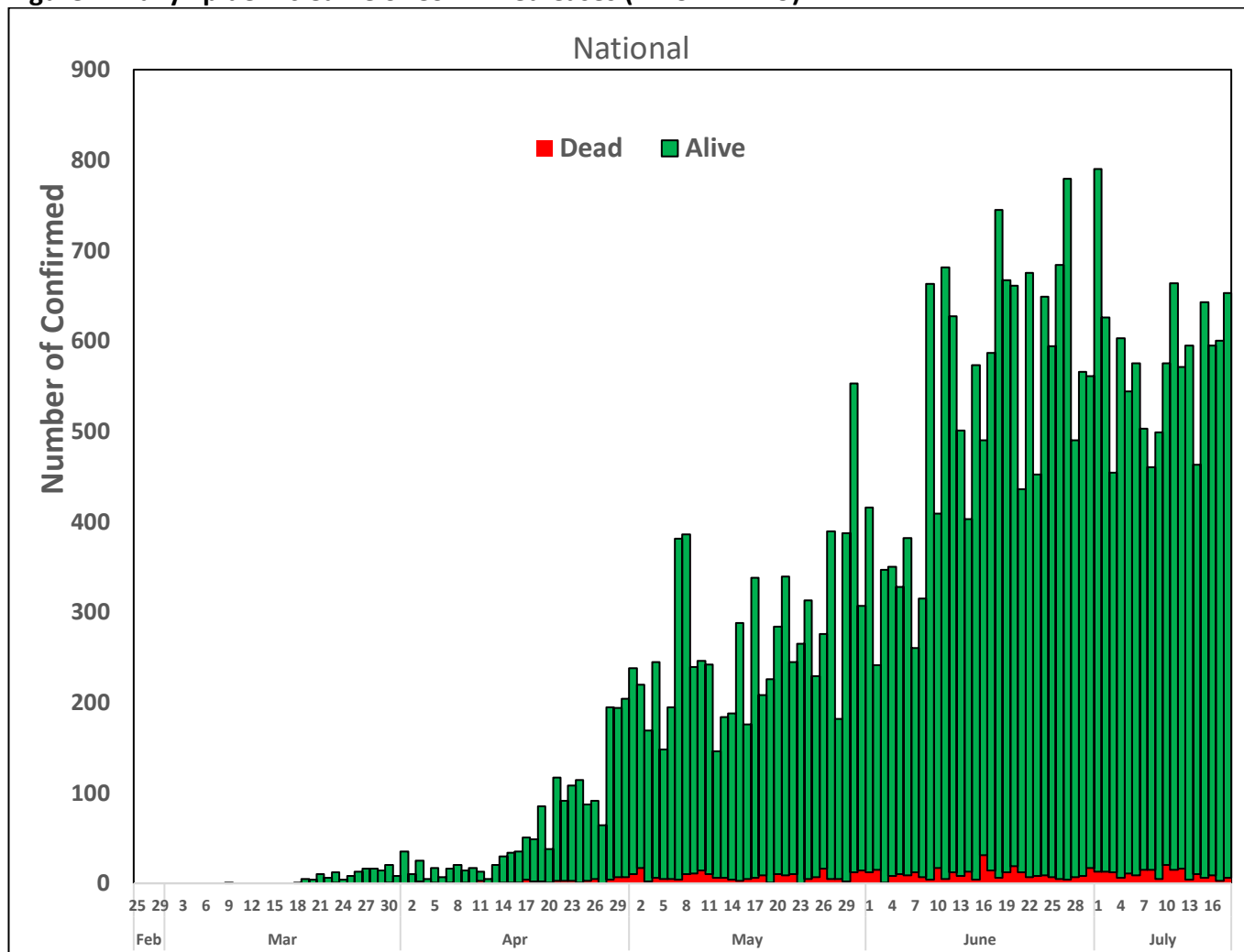
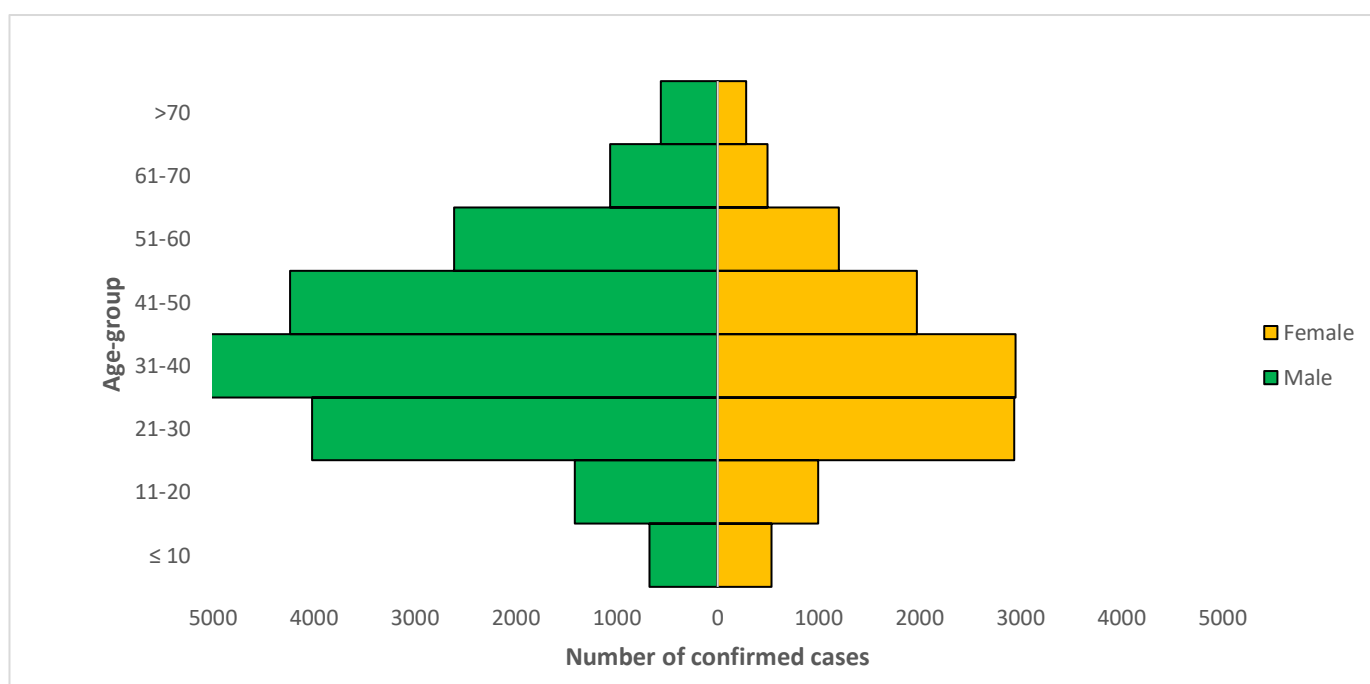


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK29)



PREPAREDNESS

Since the confirmation of the first case on 27th February 2020, the NCDC has released advisories and statements to help Nigerians and affected groups in particular to respond to the pandemic

- NCDC has launched an online course on [Infection, Prevention and Control \(IPC\) for COVID-19](#) NCDC eLearning platform
- Ahead of forthcoming elections in the country, NCDC has issued [Guidelines for Conducting Elections During the COVID-19 Outbreak in Nigeria](#).
- To protect our elders, and those with pre-existing medical conditions, NCDC has issued an [Advisory for Vulnerable Groups](#).
- NCDC has released [guidelines on the re-opening of places for worship](#).
- The Nigeria Police Force has released COVID-19 operational guidelines for the [Police and other Law Enforcement Agencies](#) in Nigeria
- NCDC and the Department of Hospital Services (Federal Ministry of Health) have updated the [case management guidelines](#) (version 3) with reviewed changes such as the discharge criteria and medication being used for the treatment of cases

RESPONSE

On 28th February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Daily tracking of sample collection by states to monitor case finding efforts**
- **Received a total of 279 Persons of Interest (POIs)/returnees from China (9), Lebanon (37), India (196) and Guinea Conakry (37) at Muritala Mohammed International Airport (MMIA) Lagos**
- **All returnees were received, screened and given the travellers kit on arrival at the airport**
- **All returnees were issued COVID-19 test appointment at Infectious Disease Hospital (IDH), Yaba, Lagos**
- **Activated three new laboratories - Edo Specialist Hospital, Benin, Edo; Abubakar Tafawa Balewa University Teaching Hospital, Bauchi; and Indoama Company Molecular Laboratory, Rivers**
- **Trained 13 laboratory personnel on IPC measures for safe sample collection in Abia State**
- **Supplied another batch of Personal Protective Equipment (PPE) to laboratories at Bayero University, Kano and University of Benin Teaching Hospital, Edo**

- Continued support to state coordination teams on Incident Action Plan (IAP) activities implementation
- Ongoing weekly data quality monitoring and engagement of State Epidemiologists (SEs) and State Surveillance Officers (SSO)
- Conducted supervisory visits to hospitals in Abuja to guide the setting up of temporary holding areas
- Procured and configured tablets to be distributed to states and treatment centres in order to strengthen data management of the national supply chain
- Distributed COVID-19 IEC materials to all states in the country
- Engaged development partners to increase support for state level activities
